No. 2 /16.26.000/2014-15—In exercise of the powers conferred by sub-section (2A) of section 24 of the Banking Regulation Act, 1949 (10 of 1949) read with section 56 thereof, and, in partial modification of the Notification UBD.BPD.(PCB).Not.No.1/16.26.000/2014-15 dated August 5, 2014 and RPCD.RCB.BC. No. 21/07.51.020/2014-15 dated August 6, 2014, the Reserve Bank hereby specifies that with effect from the fortnight beginning February 7, 2015, every Primary (Urban) Co-operative Bank shall maintain in India assets as detailed in notification UBD.BPD.(PCB).Not.No.2/ 16.26.000/2013-14 dated June 5, 2014 and every State Co-operative Bank and Central Co-operative Bank shall maintain in India assets as detailed in the Notifications RPCD.RCB.BC. No.109/07.51.020/2013-14 dated June 5, 2014 and RPCD.RCB.BC.No.15/07.51.020/2014-15 dated July 21, 2014, the value of which shall not at the close of business on any day be less than 21.5 per cent of the net demand and time liabilities in India as on the last Friday of the second preceding fortnight.

## EMPLOYEES' STATE INSURANCE CORPORATION

New Delhi, the 11th March 2015

No. A-12(11)9/2013-Estt. I.—In exercise of the powers conferred by sub-section (1) of section 97 read with clause (xxi) of sub-section (2) and sub-section (2A) of that section and sub-section (2) of section 17 of the Employees' State Insurance Act, 1948 (34 of 1948 as amended), the Employees' State Insurance Corporation with the approval of the Central Government hereby makes, the following regulations regulating the method of recruitment to the post of Commissioner (Medical Education) in the Employees' State Insurance Corporation, namely:-

1. Short title and commencement.— (1) These regulations may be called the Employees' State Insurance Corporation, Commissioner (Medical Education), Recruitment Regulations, 2015.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification, Pay Band and Grade Pay or Pay scale.— The number of posts, their classification, Pay Band and Grade Pay or Pay scale attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these regulations.

3. The Method of recruitment, age limit, qualifications, etc.— The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the aforesaid Schedule.

4. Disqualification. — No person, —

- (a) who has entered into or contracted a marriage with a person having spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post :

Provided that the Director General of the Employees' State Insurance Corporation may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these regulations.

5. Power to relax. — Where the Director General of the Employees' State Insurance Corporation is of the opinion that it is necessary or expedient to do so, he may, after taking the prior approval of the Central Government and in consultation with the Union Public Service Commission, by order, for reasons to be recorded in writing, relax any of the provisions of these regulations, with respect to any class or category of persons.

6. Savings.— Nothing in these regulations shall affect reservation and other concessions required to be provided for the Scheduled castes, the Scheduled Tribes, the Other Backward Classes and other categories of persons in accordance with the orders issued by the Central Government from time to time, in this regard.
