(परीक्षा)/नवम्बर/2012--चार्टर्ड एकाउन्टेन्ट्स रेगुलेशन, 1988 के रेगुलेशन 22 के अनुसार, दि कांसिल ऑफ दि इंस्टीट्यूट ऑफ चार्टर्ड एकाउन्टेन्ट्स ऑफ इण्डिया को अधिसूचना जारी करने में प्रसन्नता है कि वृत्तिक सक्षमता पाठ्यक्रम (पी.सी.सी.) एकीकृत वृत्तिक सक्षमता पाठ्यक्रम (आई.पी.सी.सी.) और फाइनल की परीक्षाएँ निम्नलिखित तिथियों तथा केन्द्रों पर होंगी, बशर्ते कि प्रत्येक केन्द्र में परीक्षा के लिए पर्याप्त संख्या में परीक्षार्थी निवेदन करते हैं।

उसी प्रकार चार्टर्ड एकाउन्टेन्ट्स रेगुलेशन, 1988 के अनुसूची 'सी', 'डी', 'ई', 'जी' और 'एच' के अनुसार पोस्ट क्वालिफिकेशन पाठ्यक्रमों, मैनेजमेंट एकाउन्टेन्ट्स पाठ्यक्रम (भाग-प्रथम), कांप्यूट मैनेजमेंट पाठ्यक्रम (भाग-प्रथम), टैक्स मैनेजमेंट पाठ्यक्रम (भाग-प्रथम) इन्स्योरेन्स एवं रिस्क मैनेजमेंट (आई.आर.एम.) और इन्टरनेशनल ट्रेड लॉज एंड वर्ल्ड ट्रेड ऑर्गेनाइजेशन (आई.टी.एल. एवं डब्ल्यू.टी.ओ.) की परीक्षाएँ भी निम्नलिखित तिथियों तथा केन्द्रों (केवल भारत स्थित केन्द्रों) पर होंगी, बशर्ते कि प्रत्येक केन्द्र में परीक्षा में पर्याप्त संख्या में परीक्षार्थी निवेदन करते हैं।

No. A-12(11)-1/2006-Estt. I.— In exercise of the powers conferred by sub-section (1) of section 97 read with clause (xxi) of sub-section (2) and sub-section (2A) of that section and sub-section (2) of section 17 of the Employees' State Insurance Act, 1948 (34 of 1948) and in supersession of the ESI Corporation [(Executive Engineer (Civil)) Recruitment Regulation, 1999, except as respects things done or omitted to be done before such supersession, the Employees' State Insurance Corporation hereby makes, with the approval of the Central Government, the following regulations regulating the method of recruitment to the post of Executive Engineer (Civil) in the Employees' State Insurance Corporation, namely:-

1. **Short title and commencement.**— (1) These regulations may be called the Employees' State Insurance Corporation, Executive Engineer (Civil) Recruitment Regulations, 2012.

(2) They shall come into force on the date of their publication in the Official Gazette.
2. **Number of posts, classification, Pay Band and Grade Pay/Pay scale.**— The number of posts, their classification, Pay Band and Grade Pay/Pay scale attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these regulations.
3. **The method of recruitment, age limit, qualifications, etc.**— The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said schedule.
4. **Disqualification.** — No person, —
 - (a) who has entered into or contracted a marriage with a person having spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any personshall be eligible for appointment to the said post:

Provided that the Director General of the Employees' State Insurance Corporation may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these regulations.

5. **Power to relax.**— Where the Director General of the Employees' State Insurance Corporation is of the opinion that it is necessary or expedient to do so, he may, by order, for reasons to be recorded in writing and after taking the prior approval of the Central Government and in consultation with Union Public Service Commission, relax any of the provisions of these regulations, with respect to any class or category of persons.
6. **Residuary matters.**— Subject to the provisions of these regulations, all other regulations and instructions, laid down in the Employees' State Insurance Corporation (Recruitment) Regulations, 1965, applicable to the corresponding category of posts in Employees' State Insurance Corporation, shall apply to the post specified in the Schedule annexed to these regulations.
7. **Savings.**— Nothing in these regulations shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, Ex-servicemen and other categories of persons in accordance with the orders issued by the Central Government from time to time, in this regard.

<p>Promotion:</p> <p>50 % from Assistant Executive Engineer (Civil) in Pay Band -3: Rs.15600-39100 plus Grade Pay Rs. 5400 with five years regular service in the grade. Promotion shall be subject to completion of Level 'B' training for Civil Engineers devised by the Corporation.</p> <p>50 % from Assistant Engineer (Civil) in Pay Band -2 : Rs. 9300-34800 plus Grade Pay Rs. 4600 with seven years regular service in the grade and possessing degree in civil engineering from a recognised university or any other equivalent qualification. Promotion shall be subject to completion of level 'B' training for Civil Engineers devised by the Corporation.</p> <p>Provided that departmental Assistant Engineer (Civil) with seven years regular service in the grade and possessing diploma in civil engineering from a recognized university or any other equivalent qualification as on the date of notification of the revised Recruitment Regulations for the post shall also be considered for promotion. Promotion shall be subject to completion of level 'B' training for Civil Engineers devised by the Corporation.</p> <p>Note 1: Those persons who are due to retire within two years will be exempted from completion of such training for promotion.</p> <p>Note 2: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service, or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.</p> <p>Note 3: For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 1.1.2006 or the date from which the revised pay structure based on the 6th Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding pay band and grade pay/pay scale extended based on the recommendations of the Pay Commission.</p> <p>Deputation (including short-term contract):</p> <p>Officers under the Central Government or State Government or Union Territories or Autonomous Bodies or Statutory Bodies or Public Sector Undertakings</p> <p>(A) (I) holding analogous posts on regular basis in the parent cadre or department ; or</p> <p>(II) with five years' regular service in the grade rendered after appointment thereto on a regular basis in Pay Band -3: Rs. 15600-39100 with Grade Pay of Rs. 5400 or equivalent; or</p> <p>(III) with seven years' service in the grade rendered after appointment thereto on a regular basis in posts in Pay Band-2 : Rs. 9300-34800 plus Grade Pay of Rs. 4600 or equivalent ; and</p> <p>(B) (I) possessing B.E. or B. Tech. in civil engineering from a recognized university or equivalent, and</p> <p>(II) five years experience in planning, construction and execution of civil engineering projects.</p> <p>Note 1: The departmental officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.</p> <p>"Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed four years'. The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years', as on the closing date of receipt of applications."</p> <p>Note 2: For the purpose of appointment on deputation/absorption basis, the service rendered on a regular basis by an officer prior to 1.1.2006 (the date from which the revised pay structure based on the 6th Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding pay band and grade pay or pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.</p>	<p>Group 'A' Departmental Promotion Committee (for considering promotion)</p> <p>1.
